The Christ Hospital Becomes the Newest Member of the Dana-Farber Brigham Cancer Care Collaborative

In order to be forward-thinking, The Christ Hospital Health Network expanded its world-class cancer care. In the summer of 2022, we became the newest member of the Dana-Farber Brigham Cancer Care Collaborative marking the first expansion into any hospital system in the Midwest. The Dana-Farber Brigham Cancer Care Collaborative includes a select group of hospitals that have demonstrated a commitment to excellence by meeting a wide range of standards and best practices in adult medical and radiation oncology. Our providers now have access to substantial benefits that include supportive services, second opinions and educational resources. Dana-Farber Brigham Cancer Center and The Christ Hospital Health Network now collaborate on various education and training programs for physicians and clinical staff, including the Collaborative's tumor boards where complex cases are

discussed with sub-specialists at Dana-Farber Brigham Cancer Center. When patients come to The Christ Hospital Health Network, they'll see our team's commitment to everything it takes by providing the finest cancer care including access to some of the latest clinical trials and promising new therapies. "The Dana-Farber Brigham Cancer Center has a long, impressive history of providing the latest advancements in cancer care as educators, researchers and clinical trial pioneers, and as a leader in global cancer care," said Brian Mannion, MD, oncologist at The Christ Hospital Health Network. "Our team looks forward to continuing to offer highest standards of world-class cancer care in southwest Ohio." Collaborative Members have access to a variety of services customizable to their specific needs, such as virtual consults and second opinions, physician tumor boards and case conferences, physician trainings, the Direct Connect patient concierge service if a patient requires care in Boston and various other educational services.

PRECISION HEALTH

The Christ Hospital Health Network is eclipsing other healthcare organizations in the nation by leading the evolution of Precision Health, also known as pharmacogenomics. Precision Health is a new science that uses genetic testing to proactively identify and prevent adverse drug interactions. To date, our network has ten pharmacogenomics-certified pharmacists embedded in more than 30 of our primary care provider clinical practices and in several specialty practices. 55 million people in the U.S. take five or more prescription drugs regularly. Most are unaware that their unique genetic makeup can inform physicians about how medications are processed within a patient's body. As a result, many people in this country suffer adverse side effects from prescribed medications without any relief. With just a quick cheek swab, our pharmacogenomics-certified pharmacists use information in your DNA to better identify specific drug combinations and dosages that should work best for you. The pharmacists assist the patient with any needed medication adjustments and by their next doctor visit, the goal is to have everything under control. This is a partnership designed in a collaborative manner for the health of the patient because many times medications are often not fully absorbed, are absorbed too slowly, or in some cases are metabolized too quickly or at twice the dosage.

OPERATION S.M.A.R.T. HELPED TRAIN OHIO NATIONAL GUARD BEFORE DEPLOYMENT AT CHRIST HOSPITAL

50 members of the Ohio National Guard support the network in mid-January

In January of 2022, the country was in the middle of an increase in COVID-19 cases and hospitalizations. During that time, members of the Ohio National Guard began working at The Christ Hospital in Mt. Auburn to support our team members during the COVID-19 surged caused by the Omicron variant. The Guard helped decrease the burden in many clincical and non-clinical settings including food & nutrition, envorinmental services and other departments. Many in the Guard underwent training before the pandemic under Operation Cincinnati S.M.A.R.T (Strategic Medical Assets Readiness Training). In this training program, thousands of training hours were provided to hundreds of our nation's

military members in hospitals across the region including at The Christ Hospital Health Network. The program integrates interactive observation training specific to the jobs soldiers perform in their military capacity. Brad Wenstrup, Colonel in the United States Army Reserve, a practicing physician and a member of Congress, helped to coordinate that program long before the pandemic began. Colonel Wenstrup also toured the facility while the Guard was deployed. This training was essential in allowing the servicemen and women to hit the ground running in supporting our team members. GROUND-BREAKING SHOULDER IMPLANT

The Christ Hospital Health Network always strives to work with the latest cutting-edge technology. Paul Favorito, MD, orthopedic shoulder surgeon and Division Chief of the Shoulder and Upper Extremity Service at The Christ Hospital Health Network, was the first in the country to implant a new FDA-approved shoulder implant. The brand-new shoulder implant baseplate, manufactured by DePuy Synthes and part of their reverse shoulder replacement platform system, was designed in collaboration with physicians, including Dr. Favorito. This implant has wide applications for the treatment of arthritis, rotator cuff tears and fractures. This improves upon already exceptional outcomes for the patient by enhancing stability while providing a solution for bone loss in patients. Dr. Favorito says offering this specific implant at The Christ Hospital Health Network means patients will not have to travel far for the newest medical technology.



LEADER IN INTEGRATIVE MEDICINE ACQUIRED

Partnership with Alliance Integrative Medicine Expands Network in Growing Fields of Functional and Integrative Medicine

In 2022, we acquired Alliance Integrative Medicine (AIM), now known as AIM for Wellbeing, a prominent integrative medicine practice led by renowned physicians Steve and Sandi Amoils, MDs. These expanded services will allow the network to meet patients in every point of their journey, from proactive health and wellness to acute care. Many patients use AIM as a complement to traditional care. Aim for Wellbeing combines conventional healthcare, functional medicine, and alternate therapies such as acupuncture, chiropractic care and medical massage to combat common issues such as stress, pain, chronic fatigue, allergies and digestive disorders. Many patients look for alternate forms of medicine that can support musculoskeletal, cardiovascular, women's health immune system and more. Doctors Steve and Sandi Amoils are conventional medical providers who spent years traveling the world to train in integrative and holistic techniques that achieve results for their patients.

THE CHRIST HOSPITAL HAS **FIRST-OF-ITS-KIND ROBOT IN CINCINNATI**

And It's Filling Thousands of Medication Doses a Day

The Christ Hospital Health Network unveiled a new robot in the summer of 2022 to help with inpatient medication orders. The robot, called XR2, is manufactured by Omnicell and fills 95% of all inpatient medication orders as well as medications

needed to refill the automated dispensing cabinets on our hospital floors. Barcode technology and several cameras helps increase accuracy by taking human error out of the equation making it safer for all of our patients. This new tool allows our pharmacists and technicians more time for other aspects of patient care. Approximately 6,000 doses of medications are currently being dispensed every day from the XR2. This comes to 250 doses of medication per hour.



MOVE BEYOND SURVIVING OFFERS FREE EXCURSIONS TO SUPPORT BREAST CANCER SURVIVORS

At The Christ Hospital Health Network, we believe in the special connection between a patient and their doctor. Kelly McLean, MD, surgical oncologist with The Christ Hospital Health Network found a way to give back to some of her breast cancer patients. She's the board president of the non-profit group 'Move Beyond Surviving'. This group of powerful women support each by enjoying the great outdoors together. Dr. McLean brought her love of nature to breast cancer survivors by having the group host adventures from hiking and kayaking to rocking climbing and other outdoor activities. The program is free



Patients were given the option to walk a half marathon (half the floor) or a full marathon (walking the entire floor) with assistance from our team members. The event highlighted the importance of exercise being good for your heart. As part of Heart Month in February, The Christ Hospital Health Network was proud to highlight awareness of heart disease in women. The first Friday in February, team members wore red in order to 'Go Red for Women' Day. All throughout the month, providers highlighted the importance of heart health in women. Heart disease remains the number one killer of women and providing more tools and awareness is the key to reversing these trends.







THE CHRIST HOSPITAL PRIDE PARTY CELEBRATES THE LGBTQ+ COMMUNITY

The Christ Hospital Health Network supports diversity and inclusion every day. In 2022, we participated in our second annual virtual PRIDE parade. All employees were invited to show support by creating a 'float' to be entered in our virtual PRIDE parade. A panel of judges selected three winners: Parade Spirit Award, Best Float Award and Best Enthusiasm Award. We were also a proud sponsor the Pride Party 2022 at Court Street Plaza. Members and allies of the LGBTQ+ community gathered for a fun street cocktail party in June. Christian Gausvik, MD, primary care provider with The Christ Hospital Health Network, took part in the Pride Party. He says support from the healthcare system and from his office staff has been important to the success of the practice. "Representation, trust and openness are vital to a successful physician-patient relationship and perhaps that is most true in primary care," said Dr. Gausvik. "Over 50% of the LGBTQ+ community has faced discrimination in healthcare causing many to defer important visits, and there are significant health outcome disparities for the LGBTQ+ community. This leads to ongoing challenges for patients with trust and access. That is why I have been so passionate about building a practice at Hyde Park Family Medicine with The Christ Hospital Health Network that focuses on serving the LGBTQ+ community in an open and affirming way.

MUSCULOSKELETAL SERVICE LINES UPDATE

The Orthopedics team at The Christ Hospital Health Network is leading the way when it comes patient experience through a variety of efforts. The Joint & Spine Center has received the Joint Commission Advanced Certification for Total Hip and Knee Replacement, which shows a commitment to standardization by minimizing risk and providing exceptional outcomes to patients. Additionally, the orthopedics department has worked closely with others across the organization to minimize patients use of opioids before and after surgery. "The opioid sparing committee works to identify and process patients for better outcomes." said Michael Palmer, MD, medical director of the musculoskeletal service line. "By doing so, patients can be discharged faster, have minimal postoperative complications and lessen sleep disturbance." Finally, patients of our musculoskeletal service line are enrolled in Caresense - a digital care navigation, patient engagement and data collection system that allows providers to stay in constant communication with orthopedic patients. The Caresense platform utilizes phone calls, text messages, emails and app notifications at various checkpoints in the care experience, which means providers can educate, monitor, survey and communicate with them in real time. It also means that providers have excellent data to be able to adjust care accordingly. Most importantly, we can engage patients early and often, which eliminates confusion and provides an overall better patient experience.

"Caresense allows us the capability to more effectively and efficiently guide our patients through their entire joint replacement journey," said Palmer. "It leads to improved adherence to pre and post-operative protocols, higher patient satisfaction, a greater patient experience and better outcomes."
